I. ENTRY TO THE MARKET

- a. Business cards, flyers, t-shirts and all other marketing material are welcomed. To put your items in the Favour Bag is \$40 per business. If you would like to attend, it will be an additional \$25.
- b. Bags will be issued to every attendee that attends the Event. You may issue up to 5 items.
- c. No space will be reserved until payment is received. All forms and money are due by April 1, 2025.
- d. After your application has been reviewed and payment has been received, you will receive an email notifying you of your acceptance or denial into the event. Applications will be reviewed on a first come, first serve basis. Please note that Event Manager reserves the right to limit the number of vendors per category (example: jewelry, candles, art work, etc.)

II. PROCEDURE OF EVENT

- a. You will be responsible for getting the items to the Event Manager and our team will place them in the bags.
- b. This event will be held at a church, please be mindful of the items you are submitting for approval.

III. ACCEPTANCE OF MARKET

- a. A Favour Bag application must be on file before the event. It is not permissible to share your space with another business.
- b. All payments are final. No refunds.

IV. REGULATIONS

a. Firearms, alcohol, drugs and cigarettes are strictly forbidden.

VI. INCOMPATIBLE ACTIVIES

a. The following activities are prohibited within the Event: campaigning for or against any electoral candidate or ballot measure; campaigning for election to any public office; circulating an initiative or referendum petition; unauthorized solicitation; and commercial photography or videotaping.
